This is a PDF fill-in form. You can save time, and make the form more legible, by filling it in on your computer. Just type the information into the fields. You only have to type the data once. For example, when you enter your seller ID, it will automatically populate to all fields where it is needed. Then save and print. You can also print the form and fill it in by hand.

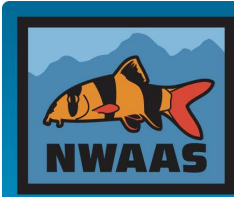
1. **Bring the the first two pages to us at the auction sign-in desk.** Please also e-mail a copy of your filled-in form to auctions@nwaas.com. This will speed things up by allowing us to pre-enter the data into the computer.

2. **The final two pages will print your item labels.** They print on standard 2-across, 20 labels per page, 1" x 4", address label stock. *Be sure to turn off "page scaling," "shrink to fit," or other options in your printer driver, or the printed labels may not line up correctly. Also turn off "duplex," or "double-sided" printing, or the two label pages will want to print on the back of each other, instead of on separate sheets.* You can also print these labels to plain paper, cut them out yourself, and then tape them onto fish bags, etc. You may want to test to see how waterproof your printer ink is, and tape over the whole label if it is not waterproof, to prevent smudging.

3. You are responsible for the correctness of your form and labels. Check your address and phone number. Remember: Both a Seller ID and telephone number must appear on each tag or you will not be paid!
